- 3. 5% rebate will be given if tax is paid for both half years at a time before 30th April of current financial year.
- 4. Property tax can be paid through: Cash or cheque at e Seva, Mee Seva centres or Municipal office or online through Creditor/Debitcard/Net Banking.
- 5. Due dates for payment of property tax without interest for current financial year: First half year 30th June, Second half year: 31st December.
- 6. A Simple interest @2% per month will be charged in case of failure to pay property tax by due dates as above.
- 7. If the tax payers fail to pay the property tax within 15 days from the date of receipt of this Demand Bill the same amount can be collected by issuing a distraint warrant.
- 8. Please bring this bill while paying at Office counter or eSeva or Mee Seva centres.
